



PROCEDURE TO BRING CARGO INTO Bonded And Re-Export ZONE AT JEDDAH SEA PORT

Please be advised that we are having covered warehouse, the best of its kind available in Saudi Arabia, within the free zone area of Jeddah seaport. We receive containers directly from the vessel into our warehouse without undergoing any customs formalities and we can store your goods safely in our bonded warehouse up to a period of 3 years or even more, pending instruction from you to release your cargo to any of your customers/ agents or assigns. We can receive full LCL or FCL containers, break bulk and Ro/Ro cargo of any type. All the cargo should be consigned to our name as follows:

We need SEA-WAY MBL copy only to bring your cargo to our warehouse and store it without paying any custom duty charges. This cargo can be moved out on any of your buyer's name having valid chamber of commerce registration to receive such goods after paying custom duty and other port charges directly to the customs thru their custom clearing agents or brokers. You have to provide the following documents to your buyer to clear the goods from Jeddah customs:

- 1. Original Commercial Invoice duly attested from Chamber of Commerce or Saudi Embassy**
- 2. Original Certificate of Origin duly attested from Chamber of Commerce or Saudi Embassy**
- 3. Packing List**
- 4. Insurance Certificate**
- 5. SASO certificate if the shipment is electric, electronic, machines or machinery parts or Ro/Ro.**
- 6. Express Release HBL.**

If you want us to clear the goods and transport to any destination within Saudi Arabia on behalf of you, we will do it by receiving the above docs from you. We will pay all the custom clearance charges and custom duty and will debit you accordingly. We will arrange transportation in closed trucks at the cheapest available rates.

We will provide you with all the official charges of MBL agent of the shipping line, Free Zone office, and sea port charges of Port dues and Stevedoring company's charges of stripping the container from the vessel at the prevailing rates of arrival of your cargo with ORIGINAL official receipts. We will pay all these charges on behalf of your esteemed company and will debit them to you in your statement of account after mutual agreement. You have to credit all these charges to us before releasing your cargo to your company or to your respective clients here in Saudi Arabia.

We give 5 days of free time and thereafter charges STORAGE CHARGES on tonnage/CBM basis per day till the cargo is moved out of our warehouse.

We also provide VALUE ADDITION services like Packing, Labeling, Re-Bagging etc at our warehouse.

A proposal for COLD BONDED PHARMA ZONE is in pipeline which will offer dedicated pharmaceutical handling/storage zone with climate-controlled chambers maintaining temperature ranges from +2°C to +8°C and from +15°C to +25°C.
